Topic: The MDM Reboot – Guiding Physicians to Tell the Full Story

**Description:** It's time to stop saying "just document more" and start teaching physicians how to document smarter. In this rebooted approach to Medical Decision Making (MDM), we'll break down how to educate providers on the why behind MDM scoring, using the 2021 CPT® guidelines and the AMA MDM grid as our foundation.

This session isn't about memorizing elements—it's about translating the auditor's lens into language a provider understands. We'll explore each of the three key MDM elements with real documentation examples, dissect common gaps, and teach you how to reframe MDM conversations in a way that leads to long-term behavior change—not just compliance for a day.

Whether you're teaching in 10-minute hallway chats or leading formal training, this session will give you the tools, tips, and trainer language to guide providers through MDM complexity with clarity and confidence.

**Topic: Split/Shared 2.0 – Who Owns the Note?** 

**Description:** As the CMS guidance evolves, the rules around Split/Shared E/M services have become anything but simple. With 2024's policy updates now in effect—and the "substantive portion" finally clarified (sort of)—auditors and compliance pros are left with one burning question: who actually gets to bill the visit?

This session dives deep into the latest CMS guidance, including the new definitions of substantive portion and what documentation is required to support it. We'll walk through real examples where both a physician and an NPP contribute to the encounter and evaluate how documentation supports either Time or MDM-based billing—and where it falls short.

Expect clear breakdowns, actionable audit insights, and educator-driven advice to help your teams confidently navigate this complex (and sometimes conflicting) territory.

**Topic: Template Nation – Are We Auditing the Doc or the Software?** 

**Description:** When every chart looks the same, it's hard to tell where the provider ends and the EMR begins. This episode digs into one of the most persistent issues facing auditors and educators today: over-templated documentation.

From default-filled H&Ps to copy-pasted MDM and time attestations, today's notes are often filled with clinically irrelevant or non-specific content that clouds the true picture of the encounter—and creates major compliance risk.

In this session, we'll explore how to:

Recognize red flags of overuse and misuse of templates,

Distinguish "convenience" from "compliance,"

And most importantly, how to educate providers on creating personalized, supportable documentation without reinventing their workflow.

We'll use real-world note examples and provide auditor-friendly phrases to support feedback without sounding like a broken record.

Identify common template-related documentation risks that affect the integrity and accuracy of E/M encounters.

Evaluate chart examples for signs of copy/paste, default text, and time attestations that lack supporting evidence.

Topic: Auditor/Educator Smackdown: Real Talk, Real Resistance

**Description:** You've done the audit. You've got the facts. Now comes the hardest part—talking to the provider. Whether you're an auditor, an educator, or somewhere in between, you've likely faced a wall of resistance, defensiveness, or flat-out disengagement.

This episode puts the spotlight on the real conversations we have with physicians, APPs, and clinical leaders when documentation misses the mark. From the classic "I've used this template for years" to the always-frustrating "No one else has ever said that," we'll role-play tough scenarios and break them down with live commentary and educator insights.

Learn how to shift the tone, reframe the feedback, and ultimately create buy-in from providers who don't always see things our way. If you've ever walked out of a feedback meeting thinking, "Did I say too much—or not enough?"—this one's for you.

Topic: Compliance MythBusters: TikTok Taught Me Wrong

**Description:** ""Just add Modifier 25 to everything."

"You don't need to document risk if the diagnosis code is accurate."

"Time? Just write '40 minutes' and you're good."

Sound familiar? If you've ever cringed while scrolling social media, this session is for you.

In this season finale, we're taking aim at the viral compliance myths, bad billing advice, and straight-up misinformation spreading on platforms like TikTok, LinkedIn, and even in some CEU circles. You'll see real posts (yes, actual examples) that have made the rounds—and get expert breakdowns of what's wrong, what's dangerous, and how to correct the narrative.

This is more than a roast—it's a teaching moment. You'll leave empowered with talking points to use with staff and providers, tips for evaluating online advice, and a few laughs at the wild things people think are "coding best practices.

**Topic: HCC & Risk Adjustment - The Denial Diaries** 

**Description:** Step into the world of denials, deletions, and documentation disasters in this eye-opening look at HCC coding and risk adjustment. As payers and plans face mounting oversight, providers are feeling the pressure—and auditors and educators are on the front lines of ensuring accuracy, clarity, and defensibility.

This session walks you through the anatomy of a risk-adjusted claim—from initial documentation to RAF scoring and retrospective audits. We'll unpack the reasons behind common denials, dissect examples of flawed vs. solid documentation, and look closely at what happens when HCCs are submitted without sufficient support.

You'll leave with a clearer understanding of RADV audits, the compliance risks surrounding HCC coding, and how to coach providers to document diagnoses in a way that reflects the patient's complexity—without turning every visit into a novel.

Explain how HCCs impact RAF scores and risk-adjusted payment models under Medicare Advantage and other risk-based systems.

Identify documentation pitfalls that commonly lead to HCC-related denials or audit failures.

Describe the RADV (Risk Adjustment Data Validation) audit process and how retrospective reviews affect provider organizations.

Evaluate real-world documentation examples for risk-adjusted accuracy, specificity, and compliance alignment.

Develop educator messaging and audit strategies that clarify HCC requirements without overburdening clinical workflows.

Topic: Auditor, Educator... Innovator: Using Al Without Losing Your Mind, Your Job, or Your Compliance

**Description:** Artificial Intelligence isn't the future—it's here. But for auditors and educators, it's hard to tell where AI fits into our highly regulated, documentation-driven world. Does it help? Can it hurt? And... do I have to learn another thing just to keep up?

This session strips away the hype and gives you a practical, honest look at how AI tools can support your work—without replacing it. You'll explore how AI is currently being used (and misused) in compliance spaces, see side-by-side comparisons of AI-generated content vs. human review, and walk away with real examples you can test safely and responsibly.

We'll also tackle the emotional burnout that comes with constant tech change—and offer strategies to manage that "I'm already behind" feeling. This isn't about becoming an expert overnight. It's about becoming confident enough to explore, adapt, and keep your edge.
